## **HNA PLAYOFF OVERTIME RULES**

- If game is tied at end of regulation, a 5-minute, sudden-death, stop time period is played.
- If still tied at end of OT period, a 5 player shootout is conducted.
- If still tied after all 5 players from each team shoot, a 4 player shootout is conducted. If tied after that round, then a 3 player shootout, then 2, then 1. In each successive shootout, the bottom player is removed. Players must shoot in the same order each round starting with A.
- If still tied after the shootouts, HNA League Tie Breakers determine the winner: 1. Points, 2. Wins, 3. Head to Head Competition, 4. Better Division Record, 5. Fewer Goals Against, 6. Goals For, 7. Fewer Team Penalty Minutes. 8. Coin Toss.
